Financial Adviser and Head of Governor's Office remained.

The Honourable Premier and Minister for Finance and Health briefed Council. According to the By-Laws of the National Commercial Bank of Anguilla (NCBA), the Board's composition is crucial for the company's good governance. The Board should comprise of seven directors with banking, finance, and business experience. Of these directors, three should be resident Anguillans. The term of office for the outgoing local directors expired in July 2024 for two local directors and August 2024 for the third director. It is proposed that two of the directors, Mr. Aidan Harrigan and Ms. Elvarie Vanterpool, be re-appointed for a period of three years. The third local director is to be sourced and proposed at a later time.

Executive Council approved the re-appointment of Ms. Elvarie Vanterpool and Mr. Aidan Harrigan as local directors of the National Commercial Bank of Anguilla for a term of three years effective 23 August 2024.
