**EX MEM 20/87 APPLICATION FOR ISSUE OF LICENCE UNDER THE ALIENS LAND HOLDING REGULATION ACT – REGISTRATION SECTION NORTH, BLOCK 59018 B, PARCEL 94 CONTAINING 0.50 OF AN ACRE**

Council agreed to issue an Aliens Land Holding Licence to hold property situated in Registration Section North, Block 59018 B, described as Parcel 94 located in Shoal Bay for private residential purposes, subject to:

- (b) the applicants be granted exemption from government’s policy restricting aliens to purchase no more than half an acre of land on the grounds that Parcel 94 is already alienated land which is being sold by a non-belonger of Anguilla as a whole is justifiable; and
- (c) with the expressed condition that the land is to be used for residential purposes and that the licencees must not rent the dwelling house without first notifying the Ministry of Lands.
