SPECIAL ADVISER TO THE MINISTER ACT, 2015

An Act to provide for the appointment of a special adviser to a Minister.

[Gazette Dated: , 2015] [Commencement: Section 3]

ENACTED by the Legislature of Anguilla

Appointment of special adviser

1. (1) A Minister of Government may, after consultation and with the prior approval of Executive Council appoint a special adviser for the purpose of providing assistance to that Minister.

(2) A special adviser shall perform such role and duties and be paid such salary and other emoluments in accordance with the terms and conditions of the written contract entered into between the special adviser and the Government of Anguilla.

Special adviser not an office of emolument in the service of the Crown or a public office

2. The office of special adviser shall not be -

(a) an office of emolument in the service of the Crown for the purposes of section 37(1)(c) of the Anguilla Constitution Order, 1982; and

(b) a public office as defined in section 73 of the Anguilla Constitution Order, 1982.

Citation and commencement

3. (1) This Act may be cited as the Special Adviser to the Minister Act, 2015.

(2) This Act is deemed to have come into force on 1st May, 2015.

SPECIAL ADVISER TO THE MINISTER BILL, 2015

OBJECTS AND REASONS

(The objects and reasons do not form part of this Bill)

The purpose of this Bill is to make provision for the creation of the office of special adviser to the Minister. The office of special adviser to the Minister shall not be an office of emolument in the service of the Crown or a public office for the purposes of sections 37(1)(c) and 73 of the Anguilla Constitution Order, 1982.
