## ELECTION REGISTRATION REGULATIONS, 2020

## REGULATIONS

Regulations made by the Governor under section 97 of the Elections Act, 2019 (Act No.18/2019).

**Interpretation**

1. (1) In these Regulations—

“Act” means the Elections Act, 2019 (Act No. 18/2019);

“building”, in relation to a polling division, means—

- (a) a public building in the polling division; or
- (b) if no public building is located in the polling division, any building;

“Central Electoral Office” means the office set up in accordance with section 2 of the Act;

“interested persons” means the—

- (a) witnesses that are permitted by the Supervisor of Elections to attend a hearing of a claim or objection in accordance with sections 23(4) and 24(2); and
- (b) candidates contesting the election in the single member district to which the claim or objection relates.

“political party” means any party, members of which contest an election;

“prescribed” means prescribed by the Governor.

(2) A reference to a preliminary list for a polling division is a reference—

- (a) in the case of a preliminary list for an Electoral District that comprises one polling division, to the preliminary list for the Electoral District; and
- (b) in the case of an Electoral District that comprises more than one polling division, to that part of a preliminary list that relates to a particular polling division.

(3) A person who is required to deliver a claim, notice of objection or other document to the Electoral Registration Officer may effect delivery by leaving the document addressed to the Electoral Registration Officer, or by causing it to be left at his office during office hours.

(4) A person who is required to deliver a notice or other document under the Act to a person other than the Electoral Registration Officer, may effect delivery on the person by leaving the document, or by causing it to be left—

- (a) at the address of the person as given by him for that purpose or as appearing on the relevant preliminary list or list of claimants; or
- (b) if there is no such address, at his last known residence.

#### **Administration of Central Electoral Office**

2. (1) The Central Electoral Office shall be open during regular business hours Monday through Friday, except on public holidays.

(2) The Supervisor of Elections may—

- (a) designate a Registration Officer as Electoral Registration Officer, who shall, in addition to the powers and duties assigned to him by the Supervisor of Elections or under the Act or any other enactment, be responsible for the management of the Central Electoral Office; and
- (b) appoint such staff as are necessary for the administration of the Central Electoral Office.

#### **Remuneration of officers**

3. (1) Subject to subsection (2), the Supervisor of Elections shall be paid at the rate of \$4,000 per month.

(2) Where there is an election, the Supervisor of Elections shall be paid—

- (a) in relation to a general election, an amount arrived at when the following formula is applied—

$$A = 3 \times (PS \div 12)$$

where—

$$A = \text{amount payable}$$

PS = annual salary at the lowest step of a Permanent Secretary in the employment of the Government of Anguilla as shown in the Annual Estimates of Revenue and Expenditure as approved by the House of Assembly; or

- (b) in relation to a by-election, an amount arrived at when the following formula is applied—

$$A = PS \div 12$$

where—

$$A = \text{amount payable}$$

PS = annual salary at the lowest step of a Permanent Secretary in the employment of the Government of Anguilla as shown in the Annual Estimates of Revenue and Expenditure as approved by the House of Assembly.

(3) An amount referred to in subsection (2) becomes payable on the day the Writ of Election is returned to the Governor.

(4) The following rates, or amounts, as the case may be, shall be paid to the officers below mentioned for their services in connection with the registration of voters or the holding of any election, as the case may be—

(a)	Electoral Registration Officer .....	\$2,000.00 per month
(b)	Clerk of the Central Electoral Office .....	\$1,500.00 per month
(c)	a Returning Officer of an electoral district where the election was contested .....	\$1,125.00
(d)	a Returning Officer of an electoral district where the election was uncontested .....	\$ 565.00
(e)	a Presiding Officer .....	\$1,050.00
(f)	a Poll Clerk .....	\$ 600.00
(g)	a Tally Clerk .....	\$ 150.00
(h)	a Typist for the typing of each name appearing on the official list of voters .....	\$ 1.25 per name.

(5) For exceptional reasons shown, the Governor may authorise a variation of the above rates in any particular case.

(6) If any amount is payable under this section to a person who is appointed to a public office other than one referred to in this section, that amount shall be payable as an allowance.

(7) For greater certainty in any month when an amount referred to in subsection (2) is payable, that amount shall be paid instead of the rate referred to in subsection (1).

#### **Travelling**

4. For travelling in connection with an election or the registration of voters, officers shall be paid at the same rate that is payable to public officers for travel allowance.

#### **Statement of candidature**

5. (1) Any person who wishes to contest an election shall indicate to the Supervisor of Elections in writing whether he wishes to contest in the single member district or the single island wide district.

(2) Where candidates from the same political party contest an election, the secretary of the political party shall file with the Supervisor of Elections a certified joint statement made by such candidates according to Form 1 Schedule 1.

#### **Symbols for ballot paper**

6. (1) There shall be printed upon every ballot paper opposite the name of every candidate who has been allocated a symbol the appropriate symbol, being one of the symbols shown in Schedule 2.

(2) Notwithstanding subsection (1), where a candidate wishes to have a symbol allotted to him that is not included in the list of symbols shown in Schedule 2, he shall apply to the Supervisor of Elections in writing to have that symbol allotted to him.

**Party symbol**

7. The same symbol may be allotted to every candidate from the same political party, if so requested by that political party.

**Allotment of symbols**

8. Allotment of symbols shall be at the discretion of the Supervisor of Elections, but so far as possible he shall allot to each political party or individual candidate the symbol requested.

**Form of list of voters**

9. The names in each preliminary list of voters shall be arranged in alphabetical order on Form 2 Schedule 1 as determined by the Supervisor of Elections and shall be numbered consecutively beginning with the number one.

**Continuous registration of voters**

10. (1) A person—

- (a) who is qualified or will be qualified on the next qualifying date to be registered as a voter in an Electoral District and who is not registered on the existing register of voters for that Electoral District; or
- (b) whose name appears on the existing register of voters for an Electoral District and who has changed his name, address or occupation but who remains qualified to be registered as a voter in that Electoral District;

may appear in person at the Central Electoral Office and submit to the Electoral Registration Officer an application in Form 3 Schedule 1 of the Act, to be registered on the quarterly list of voters for the relevant Electoral District.

(2) A person whose name appears on the existing register of voters for an Electoral District and who has changed address and is ordinarily resident in an Electoral District other than the one in which he is registered may appear in person at the Central Electoral Office and submit to the Electoral Registration Officer an application in Form 4 Schedule 1 of the Act, to be registered on the quarterly list of voters for the relevant Electoral District.

(3) The Electoral Registration Officer may make inquiries and request and review documents that he considers necessary to determine whether on the next qualifying date the person referred to in subsection (1) or (2) is qualified or will be qualified to be registered as a voter in an Electoral District.

(4) When the Electoral Registration Officer is satisfied that the person referred to in subsection (1) or (2) is qualified or will be qualified on the next qualifying date to be registered as a voter in an Electoral District, the Electoral Registration Officer shall give to the person a certificate of provisional registration in Form 4 Schedule 1.

(5) The Electoral Registration Officer shall enter on the quarterly list of voters for the relevant Electoral District, the name, address and occupation of a person to whom a certificate of provisional registration was given under subsection (4).

**Form of quarterly lists**

11. (1) The quarterly list of voters for each Electoral District shall be in Form 3 Schedule 1.

(2) The names in each quarterly list of voters shall be arranged in alphabetical order according to the surname of the voters and shall be numbered consecutively beginning with the number one.

**Publication of quarterly lists**

12. (1) The Electoral Registration Officer shall publish the quarterly list of voters for each Electoral District not later than the 42<sup>nd</sup> day of every quarter of every year.

(2) In addition to any method of publication employed under subsection (1), the Electoral Registration Officer shall post the quarterly list of voters for each Electoral District by affixing the list, together with a revision notice in Form 5 Schedule 1, to the Central Electoral Office and to 2 buildings in the Electoral District to which the list relates.

(3) Notwithstanding subsection (1), for the 2020 Election year, the Electoral Registration Officer shall publish the quarterly list of voters for each Electoral District no later than the 49<sup>th</sup> day of the first quarter, allowing the Supervisor of Elections 5 additional days to update the list between the requirement to prepare the list on the 40<sup>th</sup> day of every quarter pursuant to section 19 of the Act and the requirement to publish the list on the 49<sup>th</sup> day of first quarter in the 2020 Election year.

**Register of voters and preliminary lists**

13. (1) The Electoral Registration Officer shall prepare the register of voters for each Electoral District on a quarterly basis in accordance with the Act.

(2) The Electoral Registration Officer shall, on a quarterly basis, prepare a preliminary list of voters in Form 2 Schedule 1 in accordance with the Act.

(3) The Electoral Registration Officer shall publish the preliminary list of voters for each Electoral District not later than the 72<sup>nd</sup> day of every quarter.

(4) In addition to any method of publication employed under subsection (3), the Electoral Registration Officer shall post the preliminary list of voters for each Electoral District by affixing the list, together with a revision notice in Form 6 Schedule 1, to the Central Electoral Office and to 2 buildings in the Electoral District to which the list relates.

**Forms to be available**

14. The Supervisor of Elections shall make available at the places in each Electoral District directed by the Governor a sufficient number of copies of Forms 7, 8, 9 and 10 in Schedule 1.

**Supply of forms**

15. The Supervisor of Elections shall, on the application of any person, supply forms of claim and notices of objection without charge.

**Names on more than one list and mis-spelt names**

16. (1) Any voter—

(a) whose name appears on more than one preliminary list of voters for more than one Electoral District, shall in Form 9 Schedule 1, immediately notify the Supervisor of Elections of the Electoral District in which he elects to have his name retained; or

(b) whose name is spelt incorrectly on a preliminary list of voters, shall in Form 10 Schedule 1 immediately notify the Supervisor of Elections of the inaccuracy.

(2) Any voter—

(a) whose name appears on a quarterly list of voters for more than one Electoral District, shall, in Form 9 Schedule 1 immediately notify the Supervisor of Elections of the Electoral District in which he elects to have his name retained; or

- (b) whose name is spelt incorrectly on a quarterly list of voters shall, in Form 10 Schedule 1 immediately notify the Supervisor of Elections of the inaccuracy.

**Claims to be delivered to Registration Officer**

17. (1) Any person who claims to be entitled to be registered as a voter, and who is not entered, or is entered in an incorrect manner or with incorrect particulars in the preliminary list of voters, may claim to be registered, or to be registered correctly, as the case may be, by delivering to the Supervisor of Elections a notice of claim in Form 7 Schedule 1.

(2) Upon receipt of a claim referred to in subsection (1), the Supervisor of Elections may make inquiries and request and review documents that he considers necessary to determine whether the claimant is entitled to be registered as a voter on, or whether corrections should be made in relation to the claimant to, the preliminary list of voters.

(3) Any person who—

- (a) holds a certificate of provisional registration and who is not entered or is entered in an incorrect manner or with incorrect particulars in the quarterly list of voters for an Electoral District; or
- (b) applied to be registered on the quarterly list of voters for an Electoral District and did not receive a certificate of provisional registration, but who reasonably believes he is qualified to be registered;

may claim to be registered or to be registered correctly, as the case may be, by delivering a notice of claim in Form 7 Schedule 1 to the Supervisor of Elections not later than 7 days after the first day on which the quarterly list of voters was published.

(4) Upon receipt of a claim referred to in paragraph (3), the Supervisor of Elections shall review the claim to assess whether—

- (a) the claimant is not listed, is listed incorrectly or is listed with incorrect particulars on the quarterly list of voters; and
- (b) the claim contains or is accompanied by information necessary to make the required determinations.

(5) If additional information is required, the Supervisor of Elections shall give notice to the claimant setting out what additional information is required and a statement to the effect that failure to provide the information within 7 days will result in the claim being rejected.

(6) If the claimant does not provide the information within 7 days of the date of the notice—

- (a) the claim shall be rejected; and
- (b) the Supervisor of Elections shall give notice to the claimant that the claim is rejected.

(7) If a person whose claim is rejected under subsection (6) wants to make another claim at a later time, he shall submit a new notice of claim in Form 7 Schedule 1 and subsections (4) to (6) apply to the new notice of claim.

**Publication of claims to insertion or correction**

18. The Supervisor of Elections, not later than 8 days after the first day of publishing a quarterly list of voters, shall publish for 7 days, a list in Form 13 Schedule 1, of the names of persons who claim under



section 17(3) that their names should be inserted in, or that corrections should be made to, that quarterly list of voters.

#### **Notice of objection to claims**

19. (1) Any person whose name appears on the preliminary list of voters for an Electoral District may object to the registration of any person whose name is included in the list of claimants prepared in accordance with section 18 by delivering or causing to be delivered a notice of objection in Form 8 Schedule 1 to the Supervisor of Elections.

(2) A notice under subsection (1) shall be delivered not later than 15 days after the first day on which the quarterly list of voters was published.

(3) When the Supervisor of Elections receives a notice of objection under this section, he shall immediately deliver or cause to be delivered a notice in Form 11 Schedule 1 to the person in respect of whose claim the notice of objection is given and a notice in Form 12 Schedule 1 to the person making the objection.

(4) Where the objection to registration under subsection (1) relates to the single island wide electoral district election, only a person registered in the same single member electoral district as the claimant can object.

#### **Publishing lists of objections to claims**

20. The Supervisor of Elections, not later than 16 days after the first day on which the quarterly list of voters has been published, shall publish for 12 days, a list in Form 14 Schedule 1, of names of persons included in the list of claims to whose registration notice of objection has been given.

#### **Notice of objection to registration**

21. (1) Any person—

(a) whose name appears on the existing register of voters last published for a single member Electoral District, may object to the registration of a person whose name is included on the quarterly list of voters for that single member Electoral District; or

(b) whose name appears on the preliminary list of voters for a single member Electoral District, may object to the registration of a person whose name is included on that list;

by delivering notice of objection in Form 8 to the Supervisor of Elections.

(2) A notice of an objection referred to in subsection (1)(a) or (b) shall be delivered not later than the 52<sup>nd</sup> day of each quarter.

(3) When the Supervisor of Elections receives a notice of objection under this regulation, he shall immediately deliver or cause to be delivered a notice in Form 11 to the person in respect of whose registration the notice of objection is given and a notice in Form 12 to the person making the objection.

(4) Where the objection to registration under subsection (1) relates to the single island wide electoral district election, only a person registered in the same single member electoral district as the claimant can object.

#### **Publication of objections to registration**

22. The Supervisor of Elections—

- (a) not later than 11 days after the first day of posting of a quarterly list of voters, shall publish for 17 days, a list in Form 14, of persons whose names appear on that quarterly list and to whose registration notice of objection has been given; and
- (b) not later than the 53<sup>rd</sup> day of the quarter, shall publish for 17 days, a list in Form 14, of persons whose names appear on that preliminary list and to whose registration notice of objection has been given.

### Consideration of claims

23. (1) The Supervisor of Elections shall consider all claims and objections to claims of which notice is given to him in accordance with these Regulations.

(2) Where the Supervisor of Elections—

- (a) is in receipt of a claim in relation to which no notice of objection is given; and
- (b) considers that said claim may be allowed without further enquiry;

he shall give notice in Form 15 to the claimant that his claim is allowed.

(3) Where—

- (a) no notice of objection has been given in respect of a claim; and
- (b) the Supervisor of Elections is not satisfied that a claim can be allowed without enquiry;

he shall give at least 5 clear days' notice to the claimant of the time and place of the hearing where the claim will be considered by him.

(4) On the consideration of any claim by the Supervisor of Elections—

- (a) the claimant or the objector may appear and be heard personally on the matter; and
- (b) any person appearing to the Supervisor of Elections to be an "interested person" may—
  - (i) appear and be heard in person, or
  - (ii) be represented by another person other than counsel, on his behalf.

(5) The Supervisor of Elections shall permit the claimant or the objector or other person interested, as the case may be, to give or adduce oral or documentary evidence in support of or in opposition to the claim or the objection.

(6) The Supervisor of Elections may require that the evidence tendered by any person be given upon oath or affirmation as commonly administered in a court and may administer an oath or affirmation for that purpose and may take affidavits.

(7) The Supervisor of Elections may require any person appearing before him to furnish him with such additional information as he considers necessary for a proper determination of the application and for the prevention of fraudulent registration and may of his own initiative make further inquiries for those purposes.

(8) Where any question arises as to whether any person is deemed to be Anguillian or is a British Overseas Territories citizen, the Supervisor of Elections may have recourse to the Department of Immigration, and a statement signed by on or behalf of the Chief Immigration Officer as to the status of

any such person shall, for the purposes of the proceedings and without prejudice to any other evidence before him, be sufficient evidence of the facts stated therein.

(9) The Supervisor of Elections shall inform the claimant or objector or interested person of his decision upon the claim or objection and if requested by the claimant or the objector or interested, shall in writing, give his reasons for making the decision.

#### **Consideration of objections**

24. (1) The Supervisor of Elections shall consider all objections of which notice has been given to him in accordance with these Regulations and for that purpose give at least 5 clear days' notice to the objector and to the person in respect of whose registration the notice of objection has been given, of the time and place at which the objection will be considered by him.

(2) On the consideration of any objection or other matter by Supervisor of Elections any person appearing to the Supervisor of Elections to be interested may appear and be heard in person or by any other person, other than counsel, on his behalf.

(3) The Supervisor of Elections shall permit the objector and the person in respect of whose registration the notice of objection has been given or other person interested, as the case may be, to give or adduce oral or documentary evidence in support of or in opposition to the claim or the objection.

(5) The Supervisor of Elections may require that the evidence tendered by any person be given upon oath or affirmation as commonly administered in a court and may administer an oath or affirmation for that purpose and may take affidavits.

(6) The Supervisor of Elections may require any person appearing before him to furnish him with such additional information as he considers necessary for a proper determination of the application and for the prevention of fraudulent registration and may of his own initiative make further inquiries for those purposes.

(7) Where any question arises as to whether any person is deemed to be Anguillian or is a British Overseas Territories citizen, the Supervisor of Elections may have recourse to the Department of Immigration, and a statement signed by on or behalf of the Chief Immigration Officer as to the status of any such person shall, for the purposes of the proceedings and without prejudice to any other evidence before him, be sufficient evidence of the facts stated therein.

(8) The Supervisor of Elections shall inform the objector and the person in respect of whose registration the notice of objection has been given or other interested person of his decision upon the objection and if requested by the objector, or the person in respect of whose registration the notice of objection has been given or other person interested, shall in writing, give his reasons for making the decision.

#### **Correction of lists**

25. (1) When a decision is made in relation to a claim or objection the Supervisor of Elections shall make any correction—

- (a) to a quarterly list of voters to effect his decisions in respect of any claim or objection; and
- (b) to a preliminary list of voters to effect his decisions in respect of any objection.

(2) In addition to any correction made in accordance with subsection (1), the Supervisor of Elections may—

- (a) remove duplicate entries subject to any expression of choice by persons affected as to those entries;
- (b) expunge the names of persons who are dead or subject to any legal disqualification; and
- (c) correct clerical errors;

to ensure that the preliminary list of voters is complete and accurate as a register.

#### **Objection to corrections**

26. (1) Where the Supervisor of Elections makes any correction referred to in section 16(2)(a) or (b) in a quarterly list of voters or in a preliminary list of voters, he shall give notice in Form 16 of Schedule 1 to the person affected by the correction and allow that person an opportunity of objecting to the correction and, if necessary, of being heard with respect to it.

(2) The Supervisor of Elections shall make any correction to the quarterly list of voters or preliminary list of voters, as the case may be, that is required to effect his decision in respect of any objection under this regulation.

#### **Completion of lists**

27. The Supervisor of Elections shall ensure that the quarterly or preliminary lists of voters required under the Act are completed as expeditiously as possible in time for publication of the register of voters in accordance with the Act.

#### **Certification and publication of revised quarterly lists**

28. The Supervisor of Elections shall, after revising a quarterly list of voters in accordance with sections 25 and 26—

- (a) certify two copies of the revised quarterly list in Form 18 for each Electoral District;
- (b) not later than 28 days after the first day of posting of the quarterly list, publish a certified copy of that revised quarterly list.

#### **Transfer from revised quarterly lists to preliminary lists**

29. (1) The Supervisor of Elections shall, not later than the 71<sup>st</sup> day of every quarter, transfer the names, addresses and occupations of persons named on the revised quarterly list of voters for an Electoral District to the preliminary list of voters for that Electoral District.

(2) When the name, address and occupation of a person described in section 10(2) is transferred to the preliminary list of voters for an Electoral District, the Registration Officer shall delete the name, address and occupation of that person from the preliminary list of voters for the Electoral District in which that person was previously registered.

#### **Certification and publication, etc. of revised preliminary lists**

30. (1) The Supervisor of Elections shall, after revising a preliminary list of voters in accordance with sections 28 and 29—

- (a) certify 3 copies of the revised preliminary list in Form 17 for each Electoral District;
- (b) deliver 1 certified copy of the revised preliminary list to the Electoral Registration Officer and retain the other copies; and

- (c) not later than the last day of every quarter of every year, publish a certified copy of the revised preliminary list.

(2) When published in accordance with these Regulations, the revised preliminary list of voters for an Electoral District constitutes the register of voters for that Electoral District.

(3) After the date on which the register is proclaimed to be in force, the Supervisor of Elections shall, on the application of any person during business hours and on payment of the prescribed fee, furnish the person with a copy of the register of voters.

(4) When a writ is issued, the Supervisor of Elections shall immediately transmit a certified copy of the register of voters to the Returning Officer for each Electoral District.

#### **Insertion of names in register of voters**

**31.** (1) If the Supervisor of Elections has reasonable cause to believe that the name of any voter who has been included in the preliminary list of voters for any polling division has through inadvertence been omitted from the register of voters for that polling division, the Supervisor of Elections shall ascertain by reference to the relevant preliminary list, whether the omission of that name has been made.

(2) If the omission is verified, the Supervisor of Elections shall insert in the copies of the register of voters the name, address and occupation of the voter concerned and initial the correction and shall—

- (a) notify the person whose name was omitted, of the insertion; and
- (b) send a copy of the corrected register to the Returning Officer for the Elections District concerned.

(3) The Supervisor of Elections shall not insert the name of any person—

- (a) expunged by him from the preliminary list of voters in pursuance of a decision in respect of an objection made by him under section 24; or
- (b) at any time after nomination day.

(4) When a Returning Officer receives a copy of the corrected register in accordance with this section, the Returning Officer shall give notice of the insertion to the persons whom he believes to be likely to be nominated as candidates for the relevant Electoral District or who have actually been nominated and to the presiding officer for the polling division concerned.

#### **Deletion of names from register of voters**

**32.** (1) If, during the period between the revision of any quarterly or preliminary list of voters and nomination day, the Supervisor of Elections has reasonable cause to believe that there appears on any register of voters the name of any person who is not qualified for inclusion on the register or that any insertion that has been made under section 31 is in respect of a person who is not entitled to be included in the register, he shall hold a special revision to investigate the case.

(2) The Supervisor of Elections shall give at least 5 days' notice to the person referred to in paragraph (1) of the time and place at which the special revision will take place and at that time and place consider the eligibility of the person to be included in the register of voters.

(3) If the Supervisor of Elections decides that the name of the person referred to in subsection (1) should not be included in the register of voters, he shall delete the name from the register of voters and initial the deletion on the copies of the register retained by him.

(4) The Supervisor of Elections shall—

- (a) send a copy of the corrected register to the Returning Officer; and
- (b) if the register has been transmitted to the Returning Officer under section 30(4) or 31(2)(b), send a copy of the corrected register to the Returning Officer for the Electoral District concerned.

(5) Where the Supervisor of Elections decides to hold a special revision under subsection (1) he must initiate the investigation before nomination day.

(6) When a Returning Officer receives a copy of the corrected register in accordance with this section, the Returning Officer shall give notice of the deletion to the persons whom he believes to be likely to be nominated as candidates for the relevant Electoral District or who have actually been nominated and to the presiding officer for the polling division concerned.

#### **Publication of documents**

33. (1) Where the Supervisor of Elections is required by these Regulations to publish any document, he shall publish the document by making the proper entries on the prescribed forms and making a copy of the document available for inspection by the public in his office and electronically, and in any manner that in his opinion is desirable for the purpose of bringing the contents of the document to the notice of those interested.

(2) Failure to publish a document in accordance with these Regulations does not invalidate the document.

#### **Destroying or defacing documents**

34. Any person who without lawful authority destroys, mutilates, defaces, removes or makes any alteration—

- (a) in any notice published by the Electoral Registration Officer in connection with his registration duties;
- (b) in any notice published by the Supervisor of Elections in connection with his duties; or
- (c) any copies of a document which have been made available for inspection in pursuance of these Regulations;

is liable on summary conviction to a fine of \$2,000.

#### **Inspection and copies of documents**

35. The Supervisor of Elections shall, on the application of a person, allow the person to inspect and take extracts from, or on payment of the prescribed fee, supply to that person, copies of the lists of voters for any polling division in his Electoral District and any claim or notice of objection made under these Regulations.

#### **Declarations as to age and nationality**

36. (1) The Supervisor of Elections, before registering any person as a voter, may, if he thinks it necessary—

- (a) require that person to produce a certificate of birth, or, if that is not practicable, to make a statutory declaration that he has attained the required age; and

(b) require that person to produce such other evidence, or to make such statutory declaration, respecting his qualification as a voter, as the Supervisor of Elections considers appropriate.

(2) Where a declaration is required, no fee is payable.

(3) The Supervisor of Elections shall during office hours allow any person to inspect and take a copy of a declaration referred to in subsection (1).

#### **Power to require evidence on oath or affirmation**

37. On the consideration of any claim, objection, or other matter, the Supervisor of Elections may, at the request of any interested person, or of his own volition, require that the evidence tendered by any person should be given on oath or affirmation and may administer an oath or affirmation for that purpose.

#### **False declaration**

38. Where the Supervisor of Elections is in the course of revising any preliminary list, any person, who is found to have given any statement upon oath or affirmation which he knows to be false, or does not believe to be true, is guilty of an offence and is liable on summary conviction to imprisonment for 1 year.

#### **False documentation, etc. for purpose of being registered**

39. Any person who is not qualified to be registered as a voter and who, for the purpose of being so registered, wilfully or knowingly gives any false documentation or information to a Registration Officer is guilty of an offence and is liable on summary conviction to imprisonment for 1 year or to a fine of \$10,000 or to both.

#### **Provisions as to misnomer or inaccurate description**

40. No misnomer or inaccurate description of any person or place on any list or on any notice shall prejudice the operation of these Regulations as respects that person or place, if the person or place is so designated as to be commonly understood.

#### **Repeal of Elections Registration Regulations and the House of Assembly Elections Regulations**

41. The Elections Registration Regulations R.R.A. E30-1 and the House of Assembly Elections Regulations R.R.A. E30-2 are repealed.


#### **Savings**

42. In so far as anything done under the repealed Regulations could have been done under a corresponding provision of these Regulations, it shall not be invalidated by the repeal but shall have effect as if done under that provision.

#### **Citation**

43. These Regulations may be cited as the Elections Registration Regulations 2020.
