If said dwelling house is not completed at the end of thirty (30) months, 50% of the refundable deposit will be forfeited to the Government of Anguilla. The remaining balance of 50% will be forfeited if the construction is not completed within a further 6 months. Thereafter, forfeiture proceedings for the property will be commenced by the Government of Anguilla for a period of twenty-four (24) months.
- (e) The Licensee shall fully comply with the laws of Anguilla in force from time to time including the Land Development Control Act, the Property Tax Act, the Building Regulations, the Labour Relations Act 2018 and Work Permit Regulations 2023, the Social Security Act, the Immigration and Passport Regulations and any statutory modification or re-enactment thereof and any rules or regulations made there under.

The Honourable Minister briefed Council on the memorandum which seeks approval for the proposed Small Grants Policy under the ProGrow MSE Finance Programme. It was noted that this policy aims to enhance the financial resources for Micro and Small Enterprises (MSEs) in Anguilla through provision of grants to complement existing loan facilities.

Executive Council:

- 1. Directed that under the Eligibility Criteria, businesses must be wholly owned by Anguillians /naturalised persons;
- Approved the proposed Small Grants Policy and its implementation as part of the ProGrow MSE Finance Programme;
- 3. Endorsed the eligibility criteria, subject to Point 1. above, the selection process, and conditions for grant use as outlined in the policy;
- 4. Confirmed that applicants who have received an initial grant must demonstrate ongoing compliance with tax and social security obligations to qualify for subsequent grants;
- 5. Supported the implementation of a robust monitoring and evaluation framework to ensure transparency, accountability, and programme effectiveness; and
- 6. Noted the need for a programme that provides awardees with long-term financial and operational guidance and assistance. It was noted that specialised personnel will be needed for the implementation of this programme.
