Council confirmed the minutes of the 29th Meeting of the Executive Council held on Wednesday, 8th October 2025.

EX MIN 25/240 EX MEMO 25/188 Application for Permanent Residence pursuant to Section 5 of the Anguilla Economic Residence Act-[Redacted Text]

Asharn Hodge, Economist, Ministry of Economic Development joined the meeting.

Council was briefed on the application for Permanent Residence by [Redacted Text]. This application is pursuant to Section 5 of the Anguilla Economic Residence Act R.S. A.c.A64 which allows for a person to apply for both Residence by Investment under section 3 and Residency for Tax Purposes under section 4 by fulfilling all the requirements of both programmes and provided that the requirements under section 4(1)(b) are waived.

It was noted that the application and supporting documents were reviewed, verified and analysed for each programme's committees to make a recommendation on the Principal Applicant's suitability for grant of permanent residency and tax residence.

Executive Council:

- 1. Considered and approved the application by [Redacted Text] for grant of permanent residence and tax residence status.
- 2. Directed that the Review Committees for Residence by Investment and Residence for Tax Purposes and the Select Anguilla Agency by advised of Executive Council's decision.
- 3. Instructed that the applicant be informed of the decision and that the decision letter to the applicant makes clear:
 - (i) the Government of Anguilla can only confirm compliance with tax legislation in Anguilla;
 - (ii) It makes no representations as to the effect of the status outside Anguilla and it is the responsibility of the applicant to ensure compliance with tax legislation in other applicable jurisdictions; and
 - (iii) They are to complete all requirements within 60 days, if necessary.
- 4. Instructed that the Attorney General's Chambers review the final wording of the communication, as instructed in point 3

above, between the applicant and the Ministry of Economic Development.

Mr. Carrington Mahoney, Principal Crown Counsel (Criminal) joined the meeting.

Council was briefed on the draft Anguilla Police and Criminal Evidence Bill (PACE). It was noted that PACE intends to make the conduct of prosecutions more efficient and speedy while increasing public confidence in the administration of justice. The Anguilla PACE Bill is closely modelled on the Bermuda PACE bill.

Executive Council:

- 1. Directed that the Police and Criminal Evidence Bill is published for consultation with the public and legal profession members.
- 2. Instructed that following consultation and any amendments, the legislation returns to Council for approval of introduction in the House of Assembly.
