EX MEMO 26/001 ISLAND SCHOLARSHIP AWARD 2025

The Honourable Parliamentary Secretary, Ministerial Assistant for Sports, Youth & Culture and Senior Ministerial Advisor remained.

Honourable Minister of Social Development, Education & Library, Youth and Culture recused herself.

Council considered the Memorandum submitted by the Honourable Deputy Governor seeking approval of the award of the 2025 Island Scholarship.

Council was advised that, based on the 2025 Scholarship Rank Order Listing and the results provided by the Caribbean Examinations Council, Miss Rayana L. Webster was the candidate with the best claim to the Island Scholarship. Council noted that the recommendation was consistent with the Education Act and with the amendment to the Island Scholarship Award Criteria previously approved by Executive Council in December 2025.

Council further noted that Miss Webster commenced her studies in August 2025 and is pursuing a Bachelor of Science in Chemistry, with the intention of progressing to postgraduate studies in pharmacy, and that the total cost of the scholarship would not exceed EC\$600,000.00.

EXECUTIVE COUNCIL:

1. Approved the award of the Island Scholarship for 2025 to Miss Rayana L. Webster;
2. Confirmed that the scholarship shall be tenable for a period of up to six (6) years commencing in September 2025;
3. Approved that the total cost of the scholarship shall not exceed EC\$600,000.00, in accordance with the Education Act; and
4. Authorised the relevant officers to take all necessary administrative action to give effect to this decision.

Dr. Kelly Clark, Public Sector Reform Advisor joined the meeting.

Council received for information an update from the Honourable Deputy Governor on the reform of the Anguilla Public Service.

Council was briefed on progress to date, including the development of a Draft Five-Year Public Service Transformation Strategy and Action Plan, the modernisation

of the General Orders and Public Service Commission Regulations, the establishment of an Office of the Deputy Governor, and the planned Leadership Development Programme. Council noted that the Strategy and Action Plan were scheduled to be formally launched at a public townhall event on Wednesday 21st January 2026.

Council further noted the importance of continued ministerial leadership, advocacy, and engagement to ensure the successful implementation of the reform programme.
