SUPPLEMENTARY APPROPRIATION (2023) ACT, 2023[Gazette Dated: 17th April, 2023] [Commencement: Section 2]

An Act to authorise supplementary expenditure from the Consolidated Fund of Anguilla in excess of sums appropriated for the services of the Government of Anguilla for the 2023 financial year.

ENACTED by the Legislature of Anguilla

Supplementary Appropriation

1. On the authority of a warrant issued by the Minister of Finance, there may be expended from the Consolidated Fund, such monies not exceeding in the aggregate \$ 279,212,257 indicated in respect of the services of the Government of Anguilla set out in the Schedule to this Bill, being expenditure in excess of the monies appropriated for the services of the Government of Anguilla during the financial year ending on 31st December 2023.

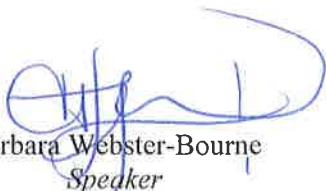

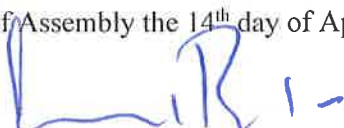
Citation and commencement
