CUSTOMS (EXEMPTION OF CUSTOM DUTIES ON FOOD ITEMS) REGULATIONS, 2023

Statutory Instruments of Anguilla No.: 10/2023

WHEREAS section 76 of the Customs Act, R.S.A. c. C169 enables the Governor in Council to make regulations in relation to tariff rates;

WHEREAS the Governor in Council did make those Regulations on 26 April, 2023;

WHEREAS section 76 of the Customs Act, R.S.A. c. C169 provides that the regulations may not take effect until it is approved by resolution of the House of Assembly;

AND WHEREAS those Regulations are set out in the Schedule hereto;

BE IT RESOLVED that, under 76 of the Customs Act, R.S.A. c. C169, the House of Assembly approves the regulations set out in the Schedule.

CUSTOMS ACT, R.S.A. c. C169

CUSTOMS (EXEMPTION OF CUSTOMS DUTIES ON FOOD ITEMS) REGULATIONS, 2023

Regulations made by the Governor in Council under section 76 of the Customs Act, R.S.A. c. C169.

Exemptions from customs duties

1. The items in the Schedule are exempt from customs duties.

Citation and commencement

2. (1) These Regulations may be cited as the Customs (Exemption of Customs Duties on Food Items) Regulations, 2023.

(2) These Regulations shall be deemed to have come into effect on 01 April, 2023 and shall come to an end on 30 June, 2023.
