Where the application is denied no fee shall be payable in relation to the application.

### TERMS AND CONDITIONS FOR BONFIRES

1. Where bonfire is being lit on a beach such bonfire is only permitted between the high tide and low tide marks
2. All bonfires will be inspected prior and post event.
3. Bonfire material must be placed on a containment box or on a piece of zinc/ galvanize and material should be stacked no higher than six (6) feet.
4. Bonfire material **shall not** consist of salt-treated lumber, pallet board, tar paper, contents containing any rubber products, creosote-treated lumber, glue-impregnated material, plastic, foam or trash.

5. Upon completion of the bonfire, all ashes and leftover material must be thoroughly wet down and disposed of in proper container(s). Material and hot ashes shall not be **buried** in the sand or disposed in a trash dumpster.
6. Bonfires shall be extinguished no later than the date and time referred to in the Application Form.
7. Cleanup and restoration of the site must be completed no later **than 8.00 am the following** day. A person to whom a bonfire Application Form is issued shall be responsible for providing the trash bags, stacking of the trash, placing all the trash in the proper **containers and disposing of trash**.
8. Where persons under the age of 18 will be in attendance at a bonfire, such persons must be chaperoned by an adult twenty-one (21) years of age or older. In such instances, the Application Form will only be issued to the chaperone.
9. Motor vehicles shall not be used to transport materials to a lit bonfire.
10. The person to whom a bonfire Application Form is granted shall at all times be present during the bonfire. Such persons shall have in his possession a copy of this Application Form and present it upon request of a representative from the Anguilla Fire Department or an Officer of the Royal Anguilla Police Force. Where a person fails to present an Application Form to the aforementioned officers, such officers may require that the bonfire be extinguished immediately.
11. A fire extinguisher, bucket, or a charge garden hose should be on standby at all times.
12. No bonfire is permitted within the bounds of any marine parks including marine parts located in **Shoal Bay East, Island Harbour, Prickly Pear, Dog Island, Sandy Island and Little Bay**).
13. The fire department is not liable for any damaged that a bonfire may cause to any property.
14. Where a bonfire is lit and no permission has been given to light such bonfire, an officer from the Fire Department or Royal Anguilla Police Force may require that the bonfire be extinguished immediately.

I accept the terms and conditions of this Application Form. I fully understand and accept the risk and dangers associated with the lighting of bonfires including, burns or other injuries that could result in partial and/or total paralysis or death and I fully accept such risks and dangers. I understand that all attendees must comply with the terms and conditions set out in the Application Form. The Anguilla Fire and Rescue Service shall not be liable for any personal injury or damages to property that may result from the lighting of the bonfire.
