Introduction

This census publication presents some of the statistical tables and their analysis from the 2001 Census. Data has also been taken to a limited extent from previous Censuses conducted in 1974, 1984 and 1992 for comparative purposes. Questions differ slightly from one survey to the next, which may affect results, as does the timing of the survey. While these differences exist, the general trend analysis is still likely to be as presented, because the differences in questions and definitions are not that significant.

The dates of the previous Censuses were:

April 7th, 1960, April 17th 1974, April 10th 1984, April 13th 1992, May 9th 2001

The tables in this publication are based upon counts of occupied private dwelling units or households. For the purposes of ensuring all residential buildings were included in the census, enumerators start out by listing all the buildings in their enumerations district they were responsible for. The buildings were then classified to establish whether they were used for residential or business purposes. Some buildings may be used for both.

The following definitions were used for purposes of the census:

Household

A household is defined as a group of people who usually sleep and share a daily meal together. People who work in St. Martin but usually come back to Anguilla for the weekend were included in the Census. For people to have been included in the census dwellings, they must have been resident or intend to be resident in Anguilla for at least 6 months.

Residential Building

A Residential Building is a separate and independent part of a building in which a person or group of people live or can live. It must have direct access from the street or common area such as a staircase or gallery where the residents can enter or leave without passing through anybody else's living quarters.

Institution

Anguilla only has three institutions, which have been included in the counts. They are the police barracks, infirmary and prison.

Private dwelling unit

A residential building can consist of one or more private dwelling units. For example a detached single house is one residential building and one private dwelling unit. An apartment building is one residential building but many private dwelling units. Private Dwelling Units may be a single house, flat, apartment, outroom, part of a commercial building, hotel or a boarding house catering for less than six persons.

Occupied Private Dwelling Unit

An Occupied Private Dwelling is simply a Private Dwelling which has a household living in it rather than being vacant. The analysis in this publication includes those dwellings, which were occupied by at least one person who had resided or intended to be resident in Anguilla for 6 months or more in 2001.

Historical Growth in Population and Households

The total number of households as of May 9 2001 was 3,787. This number is made up of 3,730 households included in the census database and 57 that were missing or refused. This represents a 44.6% increase from 1992 when the previous census was conducted. The average annual increase in households between 1984 and 1992 was 5.3%. There was a slight decline in household growth between 1992 and 2001 when average annual growth was 5.0%.

During the eighties and the nineties population growth was slower than household growth at average annual rates of 4.3% and 3.2% respectively. This indicates that there has been a continuation of the decrease in the average number of persons per household. The average number of persons per household has declined from 4.1 in 1974 to 3.6 in 1984 to 3.4 in 1992 and finally to 3.1 in 2001. (Tables 1 and 2).

While it is not possible to compare exactly districts of Anguilla from one census to the next, there is some indication of trends. North Side was included with the Valley in the 1984 census but during the nineties it was the district showing the strongest rate of growth of households and tied for first place with the Farrington in terms of population growth. While the number of households did not decline in any of the districts during the nineties, the population did decline in the East End and Blowing Point.

The district showing the highest average number of people per household in 2001 was the East End with 3.3 and the smallest number was in Sandy Ground. (Table 3).

Household Composition and Size

The percentage of single person households has increased from 21.8% in 1974 to 27.1% of all households in 2001. In contrast households with 10 or more people used to make up 5.9% of all households in 1974 and in 2001 only made up 1.1%. (Table 4)

There were 1,009 single person households, which was the most popular household composition. Couples with children numbered 878 or 23.5% of all households. The number of households, which were lone parent families, was nearly the same as couples without children at 462 and 438 households respectively.

Dwelling Unit Type

Undivided private houses were the most numerous type of Dwelling Unit in Anguilla making up nearly three quarters of all dwelling units. There were 571 apartments and 192 households living in part of a private house.

Apartments made up the greatest proportion of housing in the Valley representing 24% and the least in the Farrington with only 6%. Sandy Ground had the greatest percentage of combined dwellings and businesses with 14% and the East End the least. People living in a part of a private house was most popular in Stoney Ground and Undivided private houses represented the greatest proportion of housing in Sandy Hill. (Table 5)

Household and Land Tenure

Over two thirds of dwelling units in Anguilla were owned by those living in them. Rental Dwelling Units were most popular in The Valley with just under half being rented and ownership was greatest in The Farrington. (Table 6)

Anguillian headed households had a greater tendency to own their Dwelling Units than did non-Anguillian headed households. 83% of Anguillian headed units were owned compared to 32% for non-Anguillians. In other words there were 2,148 Dwelling Units owned by Anguillians, which they were living in, and 356 Dwelling Units with households headed up by non-Anguillians. 68% of non-Anguillian headed households rented their Dwelling Unit.

Houses had a greater tendency to be owned by the household living in them, while apartments and duplexes tended to be rented. 80% of houses were owned by the household living in them; while 81% of apartments and 76% of duplexes were rented. The household owns 60% of combined business and dwelling. (Table 7)

As is to be expected most households who owned their dwellings also owned the land, however there were 102 households which indicated that they had some other tenure arrangement for their land, many of which indicated that the land was family land. (Table 8)

Age of Housing

1,040 Dwelling Units were completed during the nineties compared to 727 during the eighties and 474 during the seventies. This means that about an average of 100 Dwelling Units were built each year. (Table 9)

Sandy Ground has the greatest proportion built prior to 1970 with 40% being built then. Stoney Ground has the greatest proportion of new housing with 43% having been built since 1990. During the eighties George Hill was the leader. The Valley had 102 Dwelling Units built prior to 1970.

Number of Rooms and Number of Occupants

In 1992 nearly half of the Dwelling Units in Anguilla had less than 3 rooms. In 2001 there were only 20% of Dwelling Units of this size. However in 1992 there were 9 with 9 or more rooms whereas in 2001 this size Dwelling Unit had declined in number to 80.

The most popular size Dwelling Unit in 2001 was one with 3 or 4 rooms being occupied by 1 or 2 people. There were 1,636 of this size, 1,559 were occupied by 1 or 2 people households. (Table 10)

Of the single room Dwelling Units in 2001, only 19% were occupied by more than 2 people, whereas in 1992, 62% were occupied by more than 2 people. More than half the Households or 2,241 were with 1 room or less per person. There were also a number of households living in spacious conditions. 219 households had more than 5 rooms per person. (Table 11).

There were 119 households where their bedrooms were not mainly for sleeping in. In other words they were used for other purposes such as sitting or eating. Of the one bedroom Dwelling Units, which comprised 594, 166 were occupied by 3 or more people. (Table 13)

Dwelling and Contents Insurance

Households who rented their dwellings were often unsure whether there was any kind of insurance on the building. Of owned dwellings, 18% possessed dwelling insurance and an even lower 9.8% owned contents insurance. Of rented dwellings 15% had dwelling insurance and 7% contents insurance.

Households who lived in a Dwelling Unit, which was a combined business and dwelling, were more inclined to have either dwelling or contents insurance. Those living in apartments were more inclined to have insurance.

Materials of Outer Walls

Most Dwelling Units in Anguilla were built of concrete. In 2001, there were 100 built of wood only and these tended to be in Blowing Point and Stoney Ground. There were 98, which were built of wood and concrete which tended to be in Sandy Ground, West End, and the Quarter. (Table 14 and 15). In 1992 there were 151 or 6% of homes built of wood compared to 3% in 2001.

Roof Materials and Pitch

The most popular roofing material for homes in Anguilla was Concrete. Just over three quarters of all Dwelling Units have concrete roofs. Nearly one fifth had sheet metal or galvanised roofs. Galvanised roofs were more popular in The Valley and Sandy Ground than other districts. (Table 16)

Just over a third of roofs in Anguilla were pitched and pitching has become more popular with roofs built since 1990. (Table 17)

Water Supply, Bathing and Toilet Facilities

The only public sources of water supply detailed in the 1992 census were from a stand pipe or public well or tank. Private sources noted in the 1992 census were Cistern or Private piped water. At this time 12.2% of dwellings used these public sources or “other” compared to 4.7% in 2001. (Table 18)

In 2001, 41% of Households noted that their main water source was from a private catchment piped into their dwelling and another 35% said that it was a cistern but not piped making up 76% or three quarters of all water supplies. The remaining 19% used public water supply either piped into their yard or into their dwelling.

The East End District was the least inclined to use public water piped into the dwelling with 2.3% of all dwellings using this water supply, tending to use a cistern, not piped. Sandy Ground leads Districts who use public water supply piped into the dwelling followed by Blowing Point and North Side. Sandy Ground and Blowing Point were also the lead districts using public standpipes. North Hill and West End were the main users of public wells or tanks. (Table 19)

Flush toilets have increased from 82% in 1992 to 93% in 2001 as the main type of toilet facility. There still remains 144 households that use a pit latrine and 78 households that have no toilet facilities. Most of these were in Stoney Ground, North Side and South Hill. (Table 20)

5% of all households who answered the question on sharing their toilet facilities indicated that they do in fact share their facilities with another household.

There were 49 households who said that they had no bathing facilities and another 171 who indicated that their bathing facilities were outside. 153 households said that they shared their bathing facilities with another household.

Main Source of Lighting

Electricity was used by 97% of households in 2001 compared to 90% having electricity in 1992. 3% of households used Kerosene in 2001 for lighting. 250 households stated that they had no electricity in 1992. In 2001, 118 households said that they used either Kerosene or had no lighting source.

Stoney Ground was the District with the greatest proportion of Kerosene users and Sandy Hill and Sandy Ground had the greatest proportion of households without a lighting source. (Table 21)

Main Source of Cooking Fuel and Location of Kitchen

Gas has increased in popularity as the main source of cooking fuel from 92% of all households in 1992 to 96% in 2001. Kerosene used to be used by 2.4% of households in 1992 and in 2001 was only used by 0.1%. Electricity has declined in popularity now being used by 1.2% of households compared to 1.5% in 1992. (Table 22).

There were 43 households who said that they had no kitchen facilities and 49 who said that their kitchens were outdoors.

Garbage Disposal

98.9% of households in 2001 said that they used a dumpster, bin or garbage truck for their garbage disposal. Burning was the second most popular method with 13 households saying that they used this method followed by dumping on land, used by 11 households.

Ownership of Selected Household Appliances or Durables

Households increased their ownership of household appliances during the nineties. 94% owned a fridge compared to 83% in 1992, 87% had a TV compared to 80% in 1992, 82% had a phone compared to 68% in 1992, 76% had a washing machine compared to 57% in 1992, 58% had a water pump compared to 37% in 1992 and 31% had a water heater compared to 16% in 1992. The percentage ownership of solar panels declined from 5% in 1992 to 4% in 2001.

There were a number of new durables included in the 2001 census. These were Cable TV (81% ownership), Stereo or Radio (90% ownership), Air Conditioning (6% ownership), Cell Phone (31% ownership), Computers (27% ownership), Internet (19% ownership), Microwave (36% ownership), VCR (47% ownership), Stove (97% ownership) and Standby Generator (10% ownership).

The District that tended to have the highest percentage ownership of household durables was George Hill followed by the Valley and West End. Interestingly, East End had the highest ownership of stereos and The Farrington the highest ownership of telephones. The Quarter had the lowest ownership of Cell Phones, Microwaves, Internet Connections, Standby Generators and Televisions. Stoney Ground had the lowest ownership of Air Conditioning, Cable TV, Fridges, and Solar Panels. (Table 23)

Vehicle Ownership

Of the 3,730 households in Anguilla, 1,135 said that they did not own a vehicle or 70% owned a vehicle in 2001.

Incidence of Vehicle ownership appears not to have changed since 1992. It has grown in line with household formation. In the 1992 census there was no separate Jeep category, jeeps were included with cars. Therefore comparing car ownership is not exactly the same. However, 49% of households in 1992 did not own a car compared to 48% in 2001.

Motorcycles were owned by 1% of households in both 1992 and 2001. 11% of households in 1992 and 13% in 2001 owned pick-ups.

Damage by Hurricane Lenny

Hurricane Lenny occurred in November 1999. Therefore households with dwellings built prior to 2000 only answered this question. 72% said that they had no financial damage. The average damage including those with zero damage was \$3,307 per household. (Table 25).

Household Income, Sources of Persons Income and Earners

The average monthly household employment income by those who responded, including those with no employment income, was EC\$3,650. There were 524 households or 15% of all households who responded who had no employment income in 2001. 31% of single person households had no employment income in 2001. (Table 26)

The modal household employment income for single and two person households was EC\$1,000 - \$1,999 monthly. For those with 10 occupants or more it was EC\$3,000 – 3,999. (Table 27).

The table below shows sources of income other than employment income for 2000. The most frequently identified source of income was Savings or Interest which 18% of the population 15 years and over said that they received in 2000.

Anguillian and Elderly Households

70% of households in Anguilla were headed by someone who holds Anguillian citizenship in 2001. The Farrington had the highest percentage of Anguillian headed households at 79% and South Hill the lowest at 64.3% followed closely by The Valley with 64.8%. (Table 29)

19% of households in Anguilla had someone who is 65 years or older. The highest percentage was in the West End with 26.3% having an elderly person and the lowest is The Valley at 14.2% followed closely by George Hill with 14.9%. (Table 28)

Of the 703 households with an elderly person, 198 were elderly people living alone.

Buildings and Building Type

During the two weeks prior to Census Day, enumerators listed the buildings in their Enumeration Districts, coded their type and tried to identify the number of occupants if the buildings were used for residential purposes. These figures are not exact but give a guide as to approximately how many buildings were vacant and the distribution of use (Table 30).

There were 5,909 buildings listed for the census of which 4,581 were used for residential purposes. Of these residential buildings, 790 did not have anyone living in them as of Census Day and 84 were classified as villas. Of all buildings 725 could not be classified but 4 had someone living in them

Rent

In 2001 there were 85 Dwelling Units that were rent-free and 1,119 that were rented or leased. The average monthly rent for these was EC\$805 and the median (Middle Rent) was EC\$650. A dwelling and business had the highest monthly rent of all Dwelling Types with an average of EC\$1,224. Apartment rents were slightly higher than houses and duplexes. There was little variation in average monthly rents by dwelling type. (Table 31)

In general rents increase with the size of dwelling with the exception of one room dwellings which had a higher average monthly rent at EC\$786 than 2 room dwellings which averaged EC\$610. The average rent for a 4 bedroom home was EC\$1,160 which the median is EC\$807 indicating that there were a few homes with relatively high rents of this size. (Table 32).

Employment Income Per Occupant

Total household income from all sources is not available from the 2001 census. Employment income was recorded. An indicator of income has been used to establish income groups which is based upon the

total household employment income per occupant. For analysis purposes the households have been divided into the following 5 income groups.

The households with zero employment income were mixed. Some of these households have other sources of income such as pensions but others were closer to very little income from any source. An analysis of ownership of selected durables in these different income ranges shows that Stoves were owned by most households regardless of income. On the other hand solar panels and air conditioning were only owned by those with higher incomes. VCRs, microwave ovens and cell phones tend to be very income sensitive. (Table 33)
