



# International Merchandise Trade Statistics Summary

## June 2010

### OVERVIEW

International merchandise trade for June 2010 at Anguilla's borders, included total imports of EC\$56.7 million and exports of EC\$3.4 million resulting in a goods deficit of EC\$53.4 million.

For the period in review, imports in the three SITC<sup>1</sup> categories – Consumption Goods, Capital Goods and Primary Goods all had higher import values compared to June 2009. In the order mentioned, each contributed 39.4%, 25.1% and 35.5% to the total import bill.

The overall increase in the value of imports (+73.1%) reflected pressures from Capital Goods (EC\$20.1 million) and Primary Goods (EC\$14.3 million).

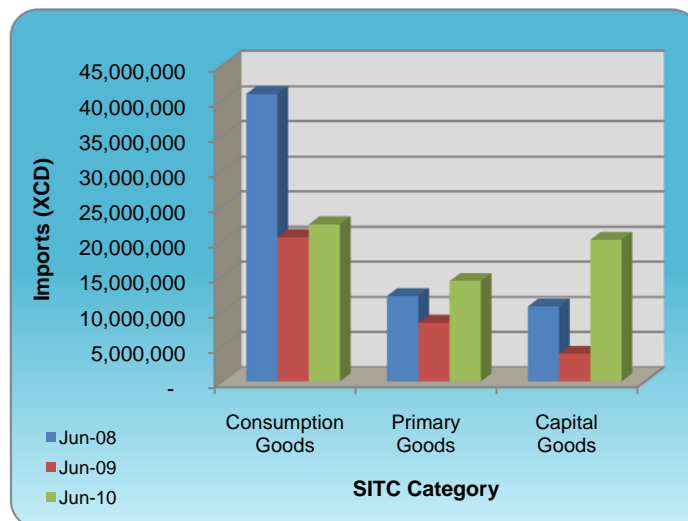


Figure 1: Imports by SITC Categories, June 2008 - 2010

### CONSUMPTION GOODS

In June 2010, Consumption Goods imports were up 8.8% to EC\$22.3 million. The increase occurred solely in the Miscellaneous Manufactured Goods component which experienced increases in a mix match of items such as house, office and garden furnishings, eating utensils, clothing and footwear.

All other components experienced declines, with the most dollar value trimmed from Food and Live Animals (-9.3%) to EC\$6.7 million and Beverages and Tobacco (-17.4%) to EC\$1.8 million. Sizeable declines were seen in the value of imports for vodka, rum, beer, poultry, dairy products, fruits and vegetables for this month.

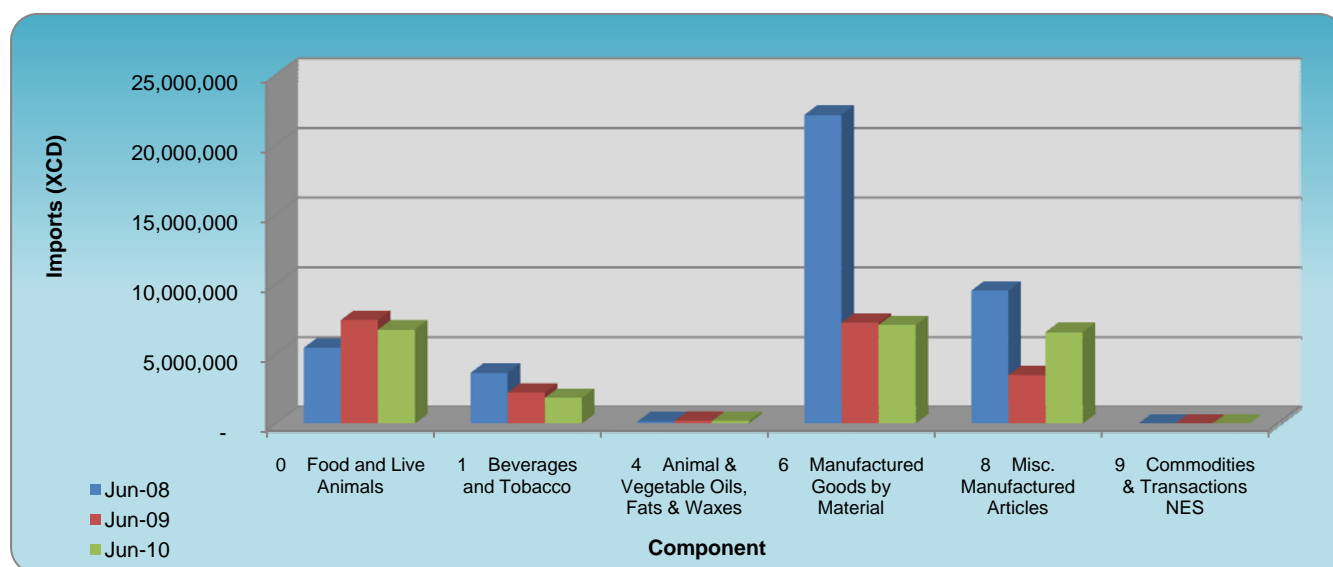


Figure 2: Consumption Goods Imports (XCD) by Component, June 2008 - 2010

## PRIMARY GOODS

Primary Goods imports increased to EC\$14.3 million, up 71.0% from the same period in 2009. The increase was led mainly by Mineral Fuels, Lubricants (+92.4%), as a result of a larger quantity of imports coupled with higher fuel prices than the same time last year.

Non-fuel items also had increases in imports with the other two components, Crude Materials,

Inedible, Except Fuels, increasing 71.5% to EC\$0.9 million.

The Mineral Fuels, Lubricants component was up 24.7% to EC\$3.1 million reflecting a year on year increase in industrial supplies and materials such as pipes, hoses and fittings; and personal care products like perfumes and bath preparations.

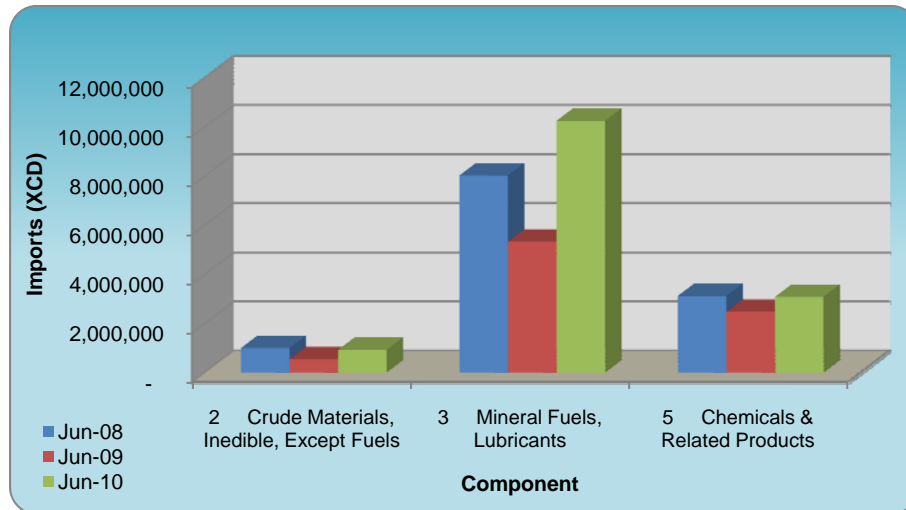


Figure 3: Primary Goods Imports (XCD) by Component, June 2008 - 2010

## CAPITAL GOODS

Imports of Capital Goods rose 415.0% from EC\$3.9 million a year ago to EC\$20.1 million. High priced commodities in the Machinery and Transport Equipment component such as generators, engines and air conditioning units led to this increase.

There was also a decline in the value of imports of motor vehicles compared to the same period in 2009 by approximately 39.7%.

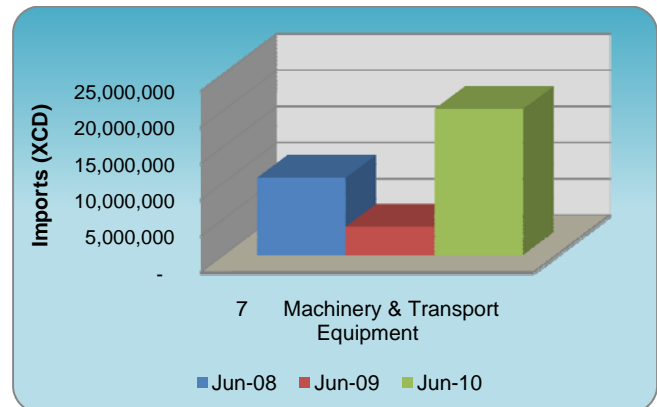


Figure 4: Capital Goods Imports (XCD) by Component, June 2008 - 2010

## EXPORTS

June exports, including both re-exports and domestic exports, declined to EC\$3.4 million, a large drop by 83.4% after a peak in June 2009.

Anguilla's balance of trade, remained in deficit this period, standing at EC\$53.4 million.

The value of trade reported represents the total record on customs documents by HM Customs and Excise Department; and does not necessarily represent the total value of goods traded during the period.

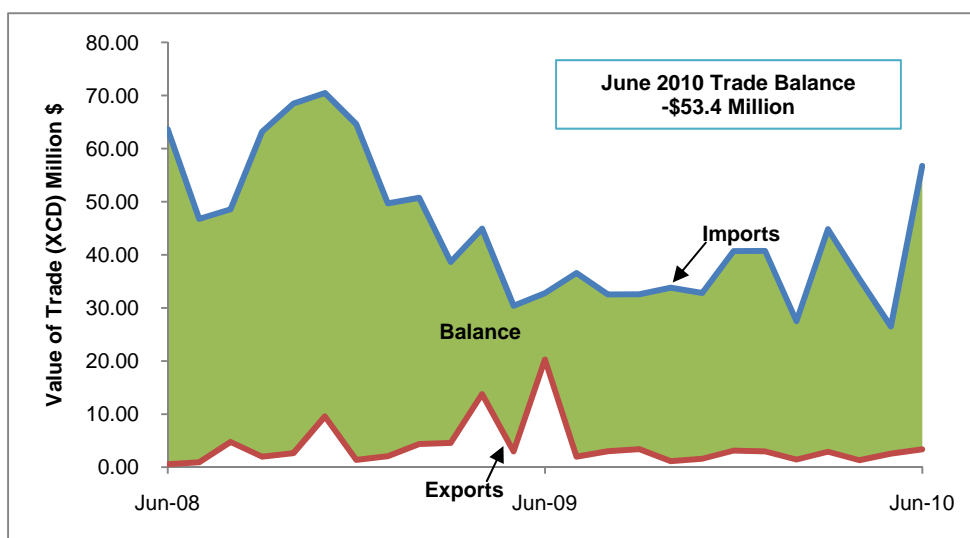


Figure 5: Anguilla International Merchandise Trade, June 2008 – 2010
