

## Anguilla: International Merchandise Trade Statistics Summary 1st Quarter, January – March 2005

There was a 49.0 percent increase in merchandise trade imports to the island during the 1<sup>st</sup> quarter in 2005 compared to 2004.


Food products, wood, rum, sand, asphalt, lawn mowers, furniture, cement, aluminum and steel products, computers, fuel and machinery were the major contributors to the increase. EC\$77.6 million dollars in goods were imported during this period compared to EC\$52.2 million in 2004.

All three months within the 1<sup>st</sup> quarter recorded increases with the month of February showing the largest increase in imports of 63.0 percent followed by March with 54.0 percent and January with a 31.1 percent increase.

EC\$9.6 million more in Capital Goods were imported for this 1<sup>st</sup> quarter 2005 than for the corresponding period in 2004, which amounted to an overall 86.0 percent rise over the first quarter of 2004. The importation of refrigeration units, mowers, computers and other machinery and parts contributed to the large increase.

Consumption Goods, which recorded the largest increase in value of EC\$11.6 million during this period rose 39.0 percent over last year's first quarter. All the components within this group showed increases over the same period last year, resulting from stronger flows in imports of alcoholic beverages, building materials and furniture.

Crude Materials except fuels, was responsible for the 37.3 percent jump in Primary Goods imports. This component increased by a whopping 189.1 percent over last year, caused by a soar in the imports of Wood, sand, asphalt



There was an increase in the value of duty collected on imported items from all three ports on Anguilla. Duty collected at the ports of Blowing Point was up 42 .0 percent, Sandy Ground (main cargo port) 20.0 percent, and the Wallblake Airport 5.0 percent.

Exports (which include re-exports and domestic exports) were valued at EC\$6.5 million, a 182 percent rise during the 1st quarter 2005 compared to last year's 1st quarter. The EC\$ 6.5 million in exports include some of the heavy equipment such as excavators, bulldozers, graders, loaders, rollers and other machines that were brought into the Island to construct and upgrade the Wallblake Airport and which are now

being re-exported. Domestic Exports accounted for 11.0 percent of the overall exports for this period. January had the largest volume in Domestic Exports for this period of EC\$480,267.

The international merchandise trade deficit for the 1st quarter was EC\$71.1million, a 42.4 percent increase compared to EC\$50.0 million in 2004.
