Anguilla: International Merchandise Trade Statistics Summary 2nd Ouarter, April – June 2003

Imports for the second quarter 2003 were down in relation to the same period for 2002. After recording a 9.4% increase in international merchandise trade imports to the island during the first quarter 2003, April – June 2003 saw a 5.2% decline compared to the same period in 2002. Imports still have not recovered to their 2001 levels. The second quarter 2003 import figure was still 11% less than that recorded for the same period in 2001. EC\$48 million worth of goods were imported between April and June 2003 compared to EC\$50.7 million in 2002.

For this period, May had the largest increase of 12.8% with June recording a slight increase of 1%. April recorded a 22.1% decline. For the first six months of the year, goods imported totaled EC\$97.2 million compared to EC\$95.7 million in 2002, resulting in a 1.6% increase, but when compared to the same period in 2001 the total value of goods imported was 15.6% less.

Beverages and crude materials (sands, wood products, iron products) were the major contributors to the decline for this period. For the 2nd quarter EC\$5.0 million less in consumption goods were imported than in the previous year, resulting in a 16.5% decline in this category. Primary goods also declined 3.7% while Capital goods increased 24.7% compared to 2002.

For the second quarter, exports amounted to EC\$2.4 million compared to EC\$3.7 million for the same period in 2002. Domestic exports accounted for 25.2% of the overall exports figure compared to 15% in 2002.

April to June 2003 had a recorded trade balance of EC\$45.5 million in deficit, a 2.9% decline compared to 2002.
