



# Anguilla Government Statistics Department

## International Merchandise Trade Statistics Summary– June 2009

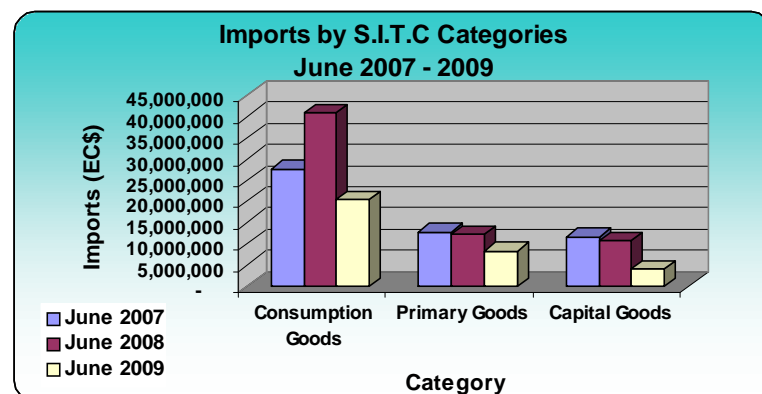
### OVERVIEW

Imports for the month of June 2009 totaled EC\$32.8 million, a decrease of 48.5% over the EC\$63.7 million in June 2008. Total imports for half of the year 2009 totaled EC\$247.1 million.

There were decreases in imports for all the S.I.T.C<sup>1</sup> categories during June 2009. The Capital Goods category experienced the largest percentage decrease with 63.3% over its corresponding 2008 figure. Consumption Goods experienced a 49.8% decrease and the Primary Goods category with a decrease of 31.4% over their corresponding 2008 figure.

Consumption, Primary and Capital Goods contributed 62.6%, 25.4% and 12.0% respectively to

the total import bill for June 2009.



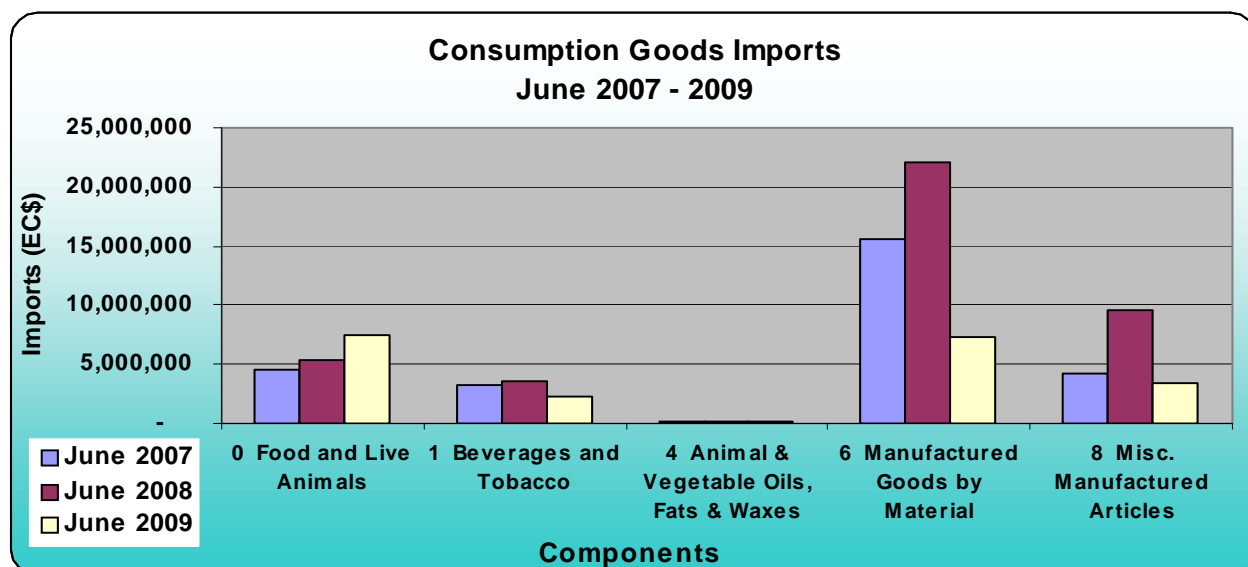

### CONSUMPTION GOODS

Consumption Goods accounted for EC\$20.5 million, 62.6% of the total imports, with all its components except 'Food and Live Animals' and 'Animal & Vegetable Oils, Fats & Waxes', experiencing decreases over their corresponding June 2008 figure,

The Manufactured Goods by Material is usually the component which contributes the most to this category. However, during this month this component experienced the largest decrease within this category of 67.3%, accounting for EC\$7.2 million, three times less its 2008 figure of EC\$22.1 million. This was partly due to the decrease in the value of imports used in the construction industry which include, plywood and blocks, especially door & windows, and steel which decrease from EC\$7.3 million to EC\$0.8 million and EC\$2.4 million to EC\$38, 261 respectively.

The component 'Food and Live Animals' contributed the largest value and increase to the Consumption Goods category with EC\$7.4 million; an increase of 36.7%. This component contributed 36.1% to the Consumption Goods category.



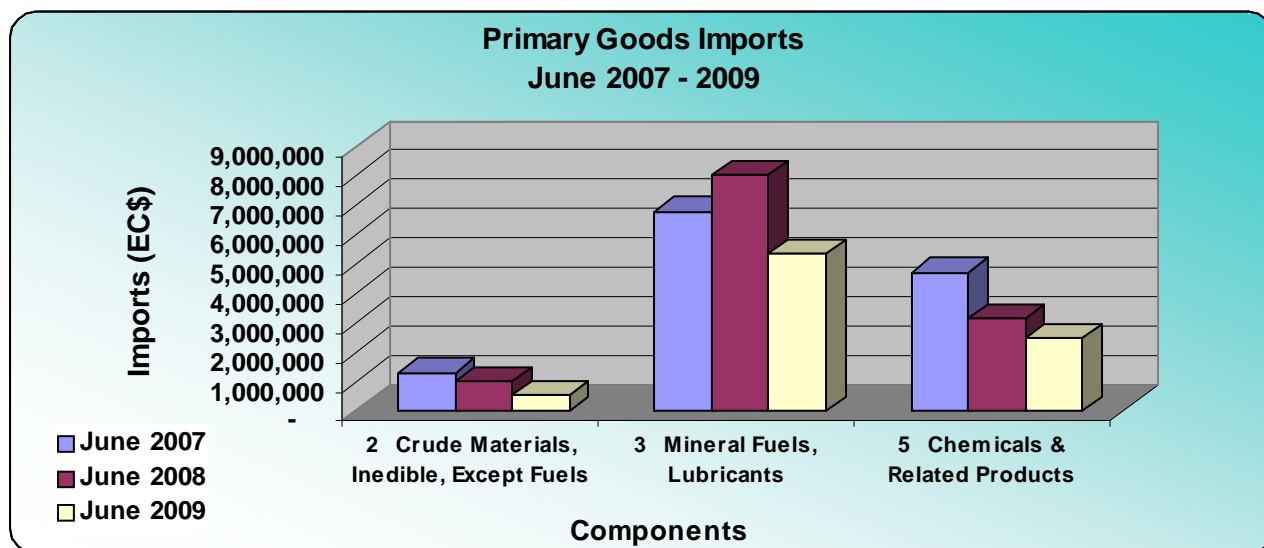
## PRIMARY GOODS

Primary Goods accounted for EC\$8.3 million of the total imports, a 31.4% decrease from its corresponding 2008 figure, with all its components experiencing a decrease.

The Mineral Fuels, Lubricants component accounted for the largest import value in the Primary Goods category, contributing 63.9% to this category with EC\$5.3 million. Conversely this component experienced a decrease in 33.6% over its corresponding 2008 figure of EC\$8.0 million. This was partly due to the decrease in value of imports such as diesel oil and petroleum jelly etc.

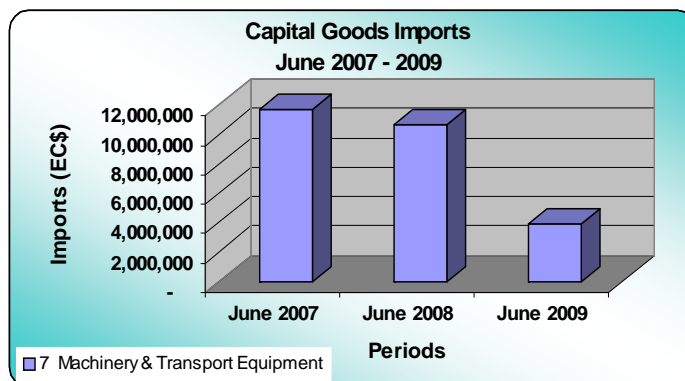
The Crude Material, Inedible, Except Fuels component experienced the largest decrease over its corresponding 2008 figure of EC\$0.5 million compared to the EC\$1.0 million in June 2008, resulting in a 46.0% decrease. This was partly due to the decrease in the import value of items such as wood, plants etc.

The Chemicals & Related Products component contributed EC\$2.5 million (29.6%) of the Primary Goods category, experiencing a decrease of 20.9% over its corresponding figure of EC\$3.1 million.



Capital Goods accounted for EC\$3.9 million, 11.9% of the total import bill, with Machinery and Transport Equipment being the sole component in this category experiencing a 63.3% decrease over its corresponding June 2008 figure.

This decrease was in part due to the decrease in the value for a number of items these such as air-conditioning units, electrical transformers, machinery and vehicle parts and vehicles which amounted to EC\$1.0 million compared to the EC\$2.5 million in June 2008.



## EXPORTS

Exports which include re-exports and domestic exports for the month of June 2009 experienced the largest value of exports to leave Anguilla of EC\$20.3 million, when compared to the corresponding June 2008 value of EC\$0.6 million. Domestic exports totaled EC\$1.3 million compared to EC\$0.2 million in June 2008; a 537.0% increase.

Anguilla's balance of trade for June 2009 was in deficit by EC\$12.5 million, a deficit decrease of 80.2% when compared to the EC\$63.1 million in the same period 2008.
