



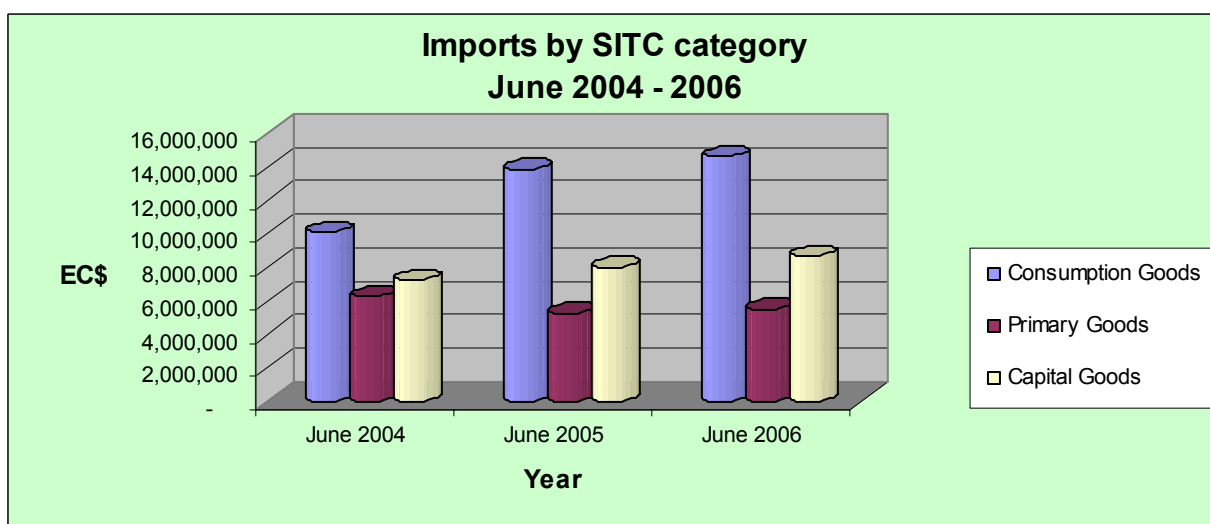
## Anguilla: International Merchandise Trade Statistics Summary June 2006

### GENERAL OVERVIEW

Imports for the month of June totalled EC\$28.8 million, a 6.3% increase over the corresponding 2005 June figure. This increase was fuelled by Consumption Goods which accounted for 50.8% of total imports. Total imports for the year were EC\$214.3 million up to the end of June 2006, a 30.3% increase over the 2005 corresponding figure.

There were increases in imports for all the S.I.T.C<sup>1</sup> categories during June 2006 with Capital Goods experiencing the greatest increase of 8.0% over its 2005 June figure. Both Consumption and Primary Goods showed increase of over 5% with, 5.6% and 5.8% respectively. Soya bean oil, vitamins, colour televisions and golf cars fuelled this increase.

The value of Consumption Goods contributed to 50.8% to the total import bill while the value of Primary and Capital Goods contributed 19.2% and 30.1% to the total import bill.



### CONSUMPTION GOODS

Consumption Goods accounted for EC\$14.6 million of the total imports, with all the groups except Beverages and Tobacco showing increases over their corresponding June 2005 figure. The Beverages and Tobacco group accounted for EC\$2.4 million of Consumption Goods' imports, however this group showed a decline of 7.1% from its June 2005 figure.

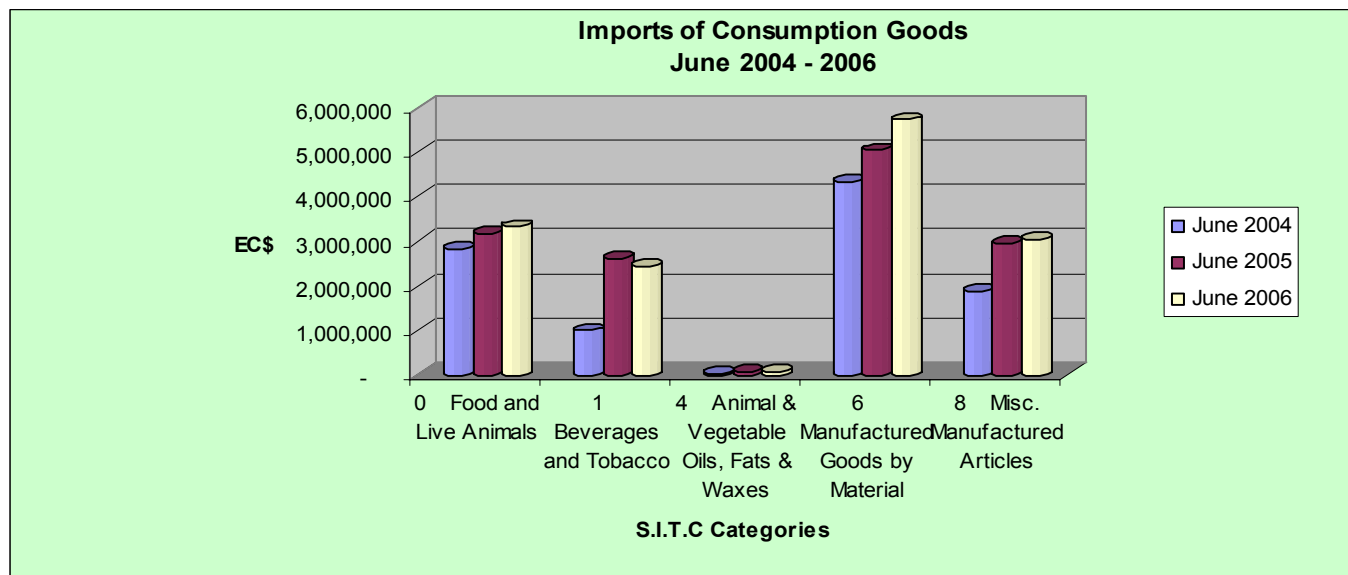
Manufactured Goods classified chiefly by Materials was the main contributor to this category and accounted for 39.2% of the Consumption Goods imports, with an increase of 13.5% over its corresponding June 2005 figure.

Animal & Vegetable Oils, Fats & Waxes was the group which experienced the largest increase of 34.2% over its June 2005 value. EC\$86,095 was the value of these imports which include Soya bean oil and animal or vegetable fats and oils.

The value of imports for the Food and Live Animals group for the month of June 2006 was EC\$3.3 million, which was 22.7% to the overall imports of Consumption Goods. This group experienced an increase of 4.5% with the increase value of import mainly fish, cereals and dairy products.

Miscellaneous Manufactured Articles, which include items such as ceramics finishings, electric lamps and men's and women's' clothing accounted for EC\$3.1 million to the EC\$14.6 million of Consumption Goods imported during the month of June 2006.



## PRIMARY GOODS

Primary Goods accounted for EC\$5.5 million of the total imports, with Mineral Fuels, Lubricant showing an increase of 53.9% over its June 2005 figure. The other two (2) groups Crude Materials, Inedible, Except Fuels and Chemicals and Related Products in this category showed declines of 46.1% and 26.1% respectively.

The decline in the Crude Materials, Inedible, Except Fuels group was, in part, as a result in the value of imports for all the chapters in this group. Ground nuts in shells and other items in this sub-chapter had the greatest decline of 75.5% over its June 2006 value.

## CAPITAL GOODS

Capital Goods accounted for EC\$8.7 million of the total imports, with Machinery and Transport Equipment, the sole group in this category experiencing the 8.0% increase. Colour Televisions was the main type of good in this group that experience the greatest increase in value over the June 2005 figure.



## EXPORTS

Exports which include re-exports and domestic exports for the month of June were EC\$1.5 million, a 48.2% decline over its June 2005 value. Domestic Export totaled EC\$1.3 million as compared to EC\$1.7 million in June 2006, a 25.2% decline.

Anguilla's balance of trade for June 2006 was in deficit by EC\$27.3 million. When compared with the same period in 2005 the deficit increased by 12.9%.
